## IMPACT OF COVID-19 PANDEMIC:<sup>2</sup>

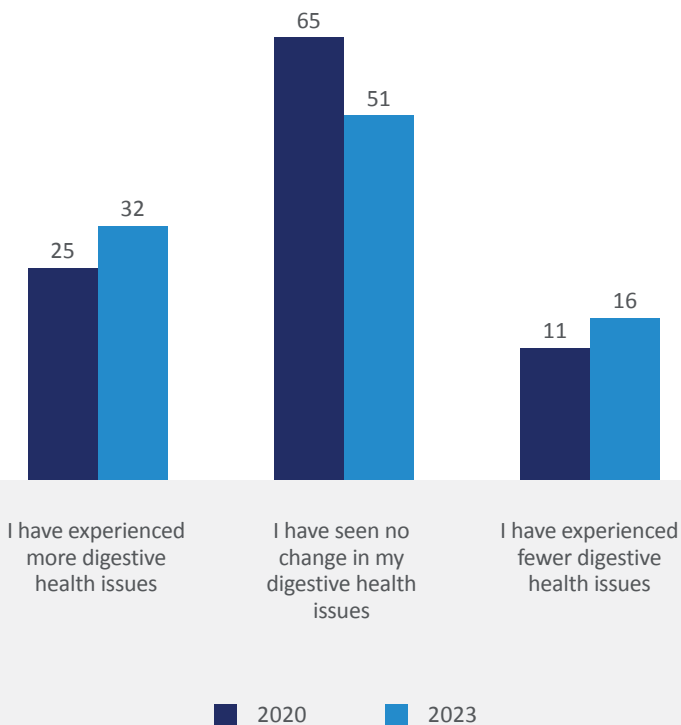
When asked, “How has your digestive health changed since the COVID-19 pandemic began or stay-at-home restrictions were put in place?”

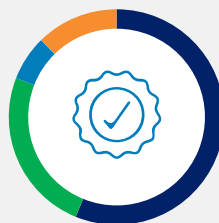
